EFFECTIVE FROM APRIL 01, 2019

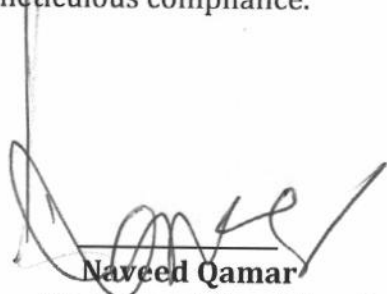
