Highlights - September 30, 2024

Macroeconomic outlook;

- ➤ Pakistan has taken key steps to restoring economic stability with consistent policy implementation under the 2023-24 Stand-by Arrangement (SBA). Growth has rebounded (2.4 percent in FY24), supported by activity in agriculture, while inflation has receded significantly, falling to single digits, amid appropriately tight fiscal and monetary policies.
- ➤ International Monetary Fund (IMF) concluded the SBA with Pakistan and approved a 37-month Extended Arrangement under the Extended Fund Facility (EFF) for Pakistan in the amount of approximately US\$7 billion out of which US\$1.03 billion has already been disbursed to Pakistan.
- > State Bank of Pakistan has been able to cut the policy rate by a total of 450 bps since June also supported by an appropriately tight FY25 budget.

Future outlook;

- > The new IMF program will require sound policies and reforms to support the authorities' ongoing efforts to strengthen macroeconomic stability, address deep structural challenges, and create conditions for a stronger, more inclusive, and resilient growth.
- ➤ Despite this progress, Pakistan's vulnerabilities and structural challenges remain formidable. The IMF projects Pakistan's GDP growth of 3.2% for FY 2025; however, sustainable recovery will require political stability, structural reforms, effective monetary policy, and controlled government spending.

MCB - Growth in Key Numbers

- Bank's total deposits crossed milestone of PKR 2 trillion mark while the domestic market share stands at 6.09% compared to 5.92% as at December 31, 2023;
- Building no cost deposits, leading to a growth of Rs. 71 billion (YoY: +9%) in average current deposits
- Cost to Income Ratio stands at 30.93% on account of 10% increase in total income;
- 8% Increase in Standalone PBT to PKR 95.1 billion;
- Consolidated PBT of PKR 103.98 billion;
- Ex-NIB related recovery FTP ended Sep-24 sums to Rs. 772 million totaling Rs. 10.4 billion since 2017;
- Home remittance inflows of USD 3.2 billion during 9M-24; depicting a market share of 12.5%.

Advances Portfolio:

- Gross advances of the Bank increased by Rs. 103 billion (+16.55%);
- Major increase in Advances is attributed to Corporate lending that increased by Rs. 93.7 billion (+21%);
- Coverage & Infection ratios of the Bank were reported at 91.98% and 7.59% respectively.

Investment Portfolio:

- PKR 206.7 billion added to Floating PIBs portfolio closing at PKR 801.8 billion;
- PKR 30.1 billion added to Fixed PIBs closing at PKR 243.5 billion;
- TBs decreased by PKR 9.7 billion and closed at PKR 345.1 billion;
- Yield on Investment increased to 19.35% in Sep-24 as compared to 17.76% in Sep-23;
- PIBs AFS & HTM excluding floating WA time to maturity of PIBs is 2.91 years.

Strong Deposit Mobilization – Two Trillion milestone:

- A rigorous deposit mobilization drive, focused on building no cost deposits, translated into an exceptional growth of PKR 259 billion in Bank's total deposit base; which surpassed the 'two trillion' mark to report at PKR 2.064 trillion (+14%) as on September 30, 2024;
- Solid growth in current deposits and saving deposits; PKR 107.4 billion (+12%) added to current and PKR 151.2 billion (17%) added to savings during 2024;
- CoD for Sep-24 contained at 9.77% (Sep-23: 8.19%);
- CASA improved to 97.17% (Dec-23: 96.81%).

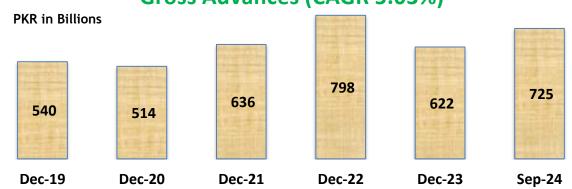

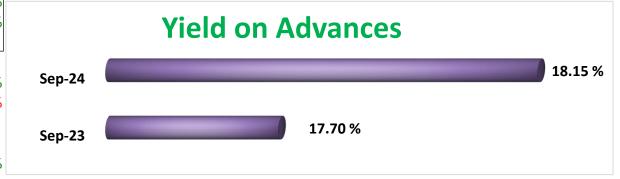

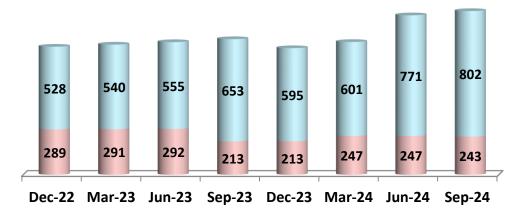

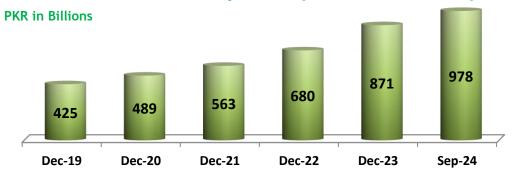

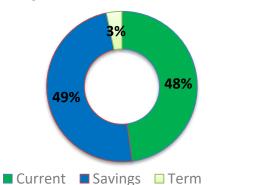
Total Deposits (CAGR: 12.50%)



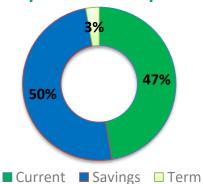
Current Deposits (CAGR: 16.73%)

Diversify Revenue Streams and Exceptional performance in Core Earnings:

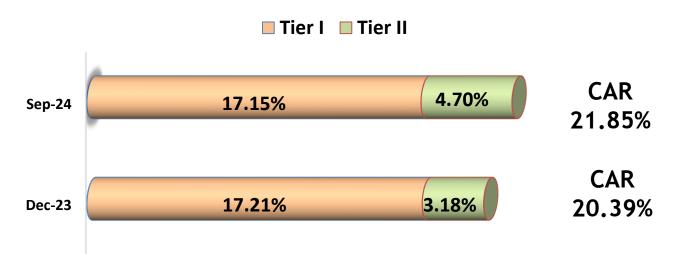
- Through focused efforts in maintaining no-cost deposits base and optimizing earning assets mix, net interest income is increased by 8%;
- Non Interest Income increased to Rs. 26.85 billion (+19%) with notable contributions from fee commission income (PKR 16.4 billion, +15%), foreign exchange income (PKR 7.5 billion, +27%), and dividend income (PKR 2.4 billion, +21%)
- Strategize to diversify its revenue streams, strong growth in fee-based income across multiple channels, including a 36% increase in card-related income, 19% growth in branch banking fees and a 54% rise in investment service commissions.
- The Bank continues to invest in digital transformation, enhancing customer experience and operational efficiency, leading to broad-based growth across digital platforms.
- Despite the high inflationary environment, MCB managed operating expenses prudently, reporting an increase of 17%, with key expenditures focused on staff costs, utilities, and IT-related upgrades, the operating expenses of the Bank were reported at Rs. 43.9 billion.
- Profit for overseas operations increased by 33%YoY to PKR 5.7 Billion (USD 20.52 million)
- PBT of Rs. 95.11 billion (+8%) while PAT registered a growth of 10%.

Profitability Ratios:

- RoE 29.98% (Dec-23: 31.60%) and RoA 2.47% (Dec-23: 2.64%), healthy profitability ratios;
- Cost to Income ratio stands at 30.93% as compared to 28.96% Sep-23.

Strong Capital Position & Ratios

Buffer of 1035bps on top of regulatory CAR





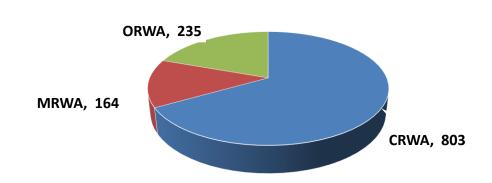
- Leverage Ratio of 6.17% which is well above the regulatory limit of 3.0%
- Liquidity Coverage Ratio (LCR) of 263.11% and Net Stable Funding Ratio (NSFR) of 153.61% against requirement of 100%.

*Minimum Capital Adequacy Ratio (CAR) of 11.50%, Common Equity Tier 1 (CET 1) ratio of 6.0% and Tier 1 ratio of 7.50%.

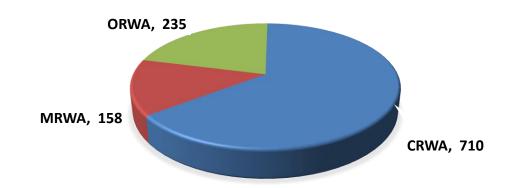
Risk Weighted Assets (RWA)

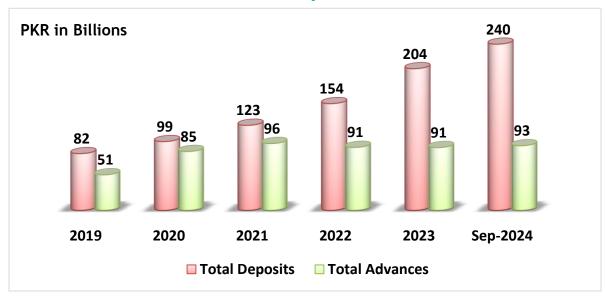

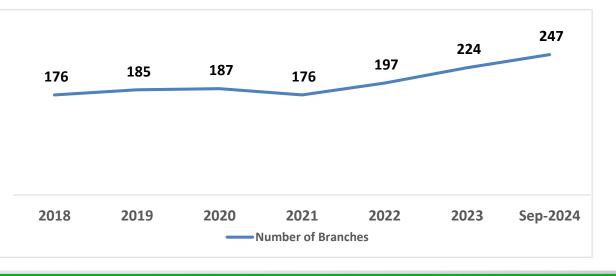
