DEFINITIONS:

Some words and expressions used in this Agreement carry specific meanings which are as follows:
"We'/ 'us'/ 'our'/ 'Bank' means to "MCB", MCB Bank Limited, a banking company incorporated under the laws of the Islamic Republic of Pakistan, having its registered office at MCB Building, F6/G6, Jinnah Avenue,

"Your' your' mean you, the customer, who is registered by MCB to use the MCB OFT Service.
"Password" means the Electronic Banking Personal Identification (secret word or combination of words & numbers used for identification) or secret Code chosen by you that is used to confirm your identity, whenever

you use the Service.

"MCB OFT Service" means MCB OFT Services provided by MCB Transaction Banking Division which shall enable you, through the Internet, to access your account, to view and obtain information available with MCB, to give instructions regarding debiting of your account; and to credit Transaction Banking Division's Collection Account For Transaction Banking Division's Corporate Customer (for which your account has been tagged by MCB) or do other transactions through your account, as allowed by MCB.
"MCB OFT Service Software" means any software supplied to you (if any) whenever you access the MCB OFT

Service and/or any other software supplied by MCB for the purpose of accessing the MCB OFT Service from time

1 ACCOUNTS ON WHICH YOU MAY USE THE MCB OFT SERVICE

By agreeing to be bound by the terms of this Agreement, you agree that the MCB OFT Service shall be available on all eligible accounts with MCB.

- The MCB OFT Service cannot be used on some types of accounts and we shall advise you from time to time as to which accounts are eligible. In order to use the MCB OFT Service, you must be registered with MCB to use the MCB OFT Service. YOUR RESPONSIBILITIES FOR SECURITY 1.1

- To ensure that you personally and exclusively access, operate alone and give instructions with respect to your accounts using the MCB OFT Service, you must adopt and at all times observe and maintain the security procedures provided here in below.

 To enable you to use the MCB OFT Service, MCB shall give you an initial login password and while communicating this initial login password to you, you will be asked to change the provided password. The user ID and Password both will be used to identify you whenever you access the MCB OFT Service. 2.2

- Safeguarding your Password

 By agreeing to these terms and conditions You hereby agree to change your Password regularly and whenever the MCB OFT Service requires you to do so. You must not choose a Password you have

 Whenever you choose a Password, you must take care not to choose a number that is likely to be guessed by anyone trying to access the MCB OFT Service pretending to be you. For example, you should avoid your own or a relative's birthday, or any part of your telephone number;
 You must take all reasonable steps to ensure that you safeguard your Password at all times. You must not disclose any details of your Password to anyone else, including any member of the MCB staff, or someone giving assistance on a technical helpdesk in connection with the MCB OFT Service;

You must not record your Password in a way that could make them recognizable by someone else as

You must not record your Password in a way that could make them recognizable by someone else as Security Codes;
If you discover or suspect that your Password or any part of it is known to someone else, you must immediately change the Password yourself through the MCB OFT Service. If this is not possible, you must notify us immediately by calling at your designated customer representative's number (or any other number we may advise you from time to time for this purpose), thereafter, we will suspend use of the MCB OFT Service until a new Password is set up.
If the password and username is conveyed via postal letter by MCB it may also be suggested that "after receipt of letter and remembering the username and password, the letter should be destroyed.

Checking your statements
If you become aware of any transaction on any of your accounts that has not been performed or.

If you become aware of any transaction on any of your accounts that has not been performed or validly authorized by you, you must notify us immediately by calling your designated customer representative's number or any other number which may be given by us from time to time. For this purpose, you are expected to check all of your bank statements for any unauthorized transaction.

 Other security safeguards
 You must not allow anyone else to operate the MCB OFT Service on your behalf.
 You must not leave Your System unattended while you are on-line to the MCB OFT Service. This applies whether Your System is a device you have sourced independently or a device provided by MCB to access the MCB OFT Service in one of MCB's branches. However, the public nature of our branches makes it particularly important that if you access the MCB OFT Service from a device in one of our branches, you must not leave that device unattended while on-line and ensure that you have logged out the said device before leaving the branch.
 You must not access the MCB OFT Service from a cyber, internet café or from any device connected to a local area network (or LAN), such as an office environment, without first making sure that no one else is able to observe or copy your access or obtain access to the MCB OFT Service pretending to be you.

 YOUR AUTHORITY TO MCB TO CARRY OUT INSTRUCTIONS

- Your AUTHORITY TO MCB TO CARRY OUT INSTRUCTIONS

 You hereby agree that the use of the Password agreed between MCB and yourself for the MCB OFT

 Service is adequate identification of you. MCB disclaims any and all liability with respect to acting on any instructions issued by you through the MCB OFT Service using your login and Password (using the Security Codes via the MCB OFT Service) without obtaining any further written or other confirmation from you, even in case those instructions are later found not to be given or authorized by you.

 Your liability for unauthorized instructions
- You shall not be liable for misuse of your Password by someone provided that you prove to MCB's
- satisfaction that you have:
 Ensured that all security procedures described in these terms and conditions have been fully observed; 3.2.1

and Notified us that your Password is or might be known to someone else in accordance with section 2.3.5; and / or you have notified MCB, immediately, in terms of section 2.4 above, of any transaction that has not been performed or validly authorized by you. You will be held liable for any and all losses and expenses due to unauthorized use of your Password, if you have acted fraudulently or, with gross negligence, with intentional misconduct or if you are in willful default of any of the security obligations described in sections 2.1 to 2.3.4 including 2.5 to 2.8 inclusive of the notification requirements of section 2.3.5.

Acting on your instructions
You must not use the MCB OFT Service to create an unauthorized overdraft on any of your accounts and MCB shall be within its rights to refuse to accept any instruction that would do so. If an unauthorized overdraft is created, MCB may take any action we think fit and charge any mark-up and charges to the account in question (in accordance with the terms and conditions of that account). You hereby agree that:

- It is your responsibility to make sure that no unauthorized overdrafts are created; and
- You shall not rely on the operation of the MCB OFT Service to prevent an unauthorized overdraft being created. In particular, you must remember that any payment instructions you have given via the MCB OFT Service might take time to clear and might not always be immediately reflected in the balance on vour account.
- When we receive a transaction instruction from you through the MCB OFT Service, MCB will be entitled to debit any payment plus any charges payable for the transaction from the account you have

specified. Once you have given an instruction through the MCB Virtual OFT Service, you will not be able to reverse it. We will be under no obligation:

To reverse an instruction you have given; or To accept an instruction that is conditional or reversible or which requires MCB to pay a third party sooner than MCB would be able to pay them following our normal banking practices. However, if you do ask MCB to reverse an instruction after you have given it, MCB may at its sole discretion try to do so to the extent that this is possible under the rules and practices of the banking system. You hereby agree that you shall be fully and completely responsible for any costs incurred by MCB as a result. MCB may in its sole discretion to:

- Refuse to carry out any instruction given via the MCB OFT Service; or

Retuse to carry out any instruction given via the MCB OF1 Service; or Require written confirmation from you of a particular instruction.

If we come to believe that an instruction may not have properly been authorized by you, MCB shall be entitled to take steps to reverse any action taken on the basis of that instruction after making reasonable efforts to check whether it was properly authorized. MCB disclaims all liability with respect to any loss to you resulting from such reversal.

You hereby undertake and agree to indemnify and hold harmless MCB, our employees and our nominees or agents promptly and on a full indemnity basis from or against all actions, omissions, negligence, proceedings, claims, demands, damages, losses (including direct, indirect or consequential losses), costs and expenses including all duties, taxes, or other levies and legal costs as between solicitor and client (on a full indemnity basis) and other liabilities which we may incur or suffer from or by reason of your use of the MCB OFT Service.

NON-COMPLIANCE WITH THE TERMS OF THIS AGREEMENT

Once you have received notice of any change in the terms of this Agreement, we will treat your subsequent use of the MCB OFT Service as your acceptance of the change.
